The coming months will require great foresight and diligence upon the representatives. Communication and accountability will be the key ingredients to help carry the message to our respective memberships.

Before I begin, I wish to take this opportunity to extend our warmest condolences to the family of Larry Brooksbank. Larry was with Five Nations from the onset of the project back in 1997. He was the technical advisor to the team. He provided invaluable insight to the technical development of the infrastructure which now provides energy to our communities. Larry's passion was impeccable, he was always there at every step of the way. During the difficult times, it was Larry who would pat the backs of the board members when the going got tough. He never stopped congratulating the team for the work they had accomplished and how successful it was. Larry's contributions helped the team to meet the objectives and expectations of the company. Larry was laid to rest in his hometown of Barrie Ontario on August 28, 2014, and we made sure his family and friends were made aware of how much he was appreciated for the commitment he provided for our communities. He will always be remembered at Five Nations Energy Inc., and from those people he came to know firsthand from the years he worked in helping to construct the first First Nations owned transmission line in Canada.

There are a few partnerships currently on the go that helps the homeowners in our communities. You may have noticed the work taking place this past year within your area. There are renovations being carried

out and work will continue for a few more years until all the units are refurbished to help in conserving energy. This work took many years to make it a reality, and with everything, planning takes time. It is the expectation that all the homes will have had work done to minimize heat loss and ways to reduce electricity costs.

Work is also in progress to consult with the membership on developing a community energy plan that would identify ways to maximize the energy output but help cut down on cost. This undertaking will commence this winter and we will be visiting the communities of Attawapiskat, Kashechewan, and Fort Albany. It will be very appreciated if you could come out and provide your input on how we can put this information together and identify what the options could be.

Earlier this summer, we had a roundtable discussion hosted by Western James Bay Telecom Network (WJBTN) on communication services outside agencies currently provide to our communities. You may have noticed the upgrades that were carried out with the transmitter installations located along the coast. This work was carried out over the two years and this exercise did not include any participation by our community owned companies. The plan is to begin discussions on taking our share of revenue that flow out of our communities. The necessary infrastructure is in place and will assist our companies to take over ownership of these services. Again, this will require cooperation amongst our communities and companies but the end goal is complete ownership. The possibilities here can only mean better access and reliability to much needed bandwidth we all wish to have within our fingertips.

During all this activity, we also had to comply with changes that were introduced three years ago by Industry Canada on corporate governance. We were able to meet the deadline of October, 2014. This exercise involved having consultations with each of the respective chiefs and councils to provide their input on two models proposed. These discussions will need to continue on the coming months because things have changed dramatically since we wrapped up these consultations. The good thing about having these community visits is the open mindedness the councils provided in leaving the door open to revisit these discussions should it become necessary. It would be prudent upon each of our member communities to have another dialogue on this subject matter soon rather than later. These discussions will be required to allow Five Nations Energy to continue moving forward.

There was also a step forward with the local distribution companies during these meetings. It was realized that these meetings proved to be beneficial and productive, and important that all our stakeholders be included in all developments Five Nations Energy is involved in. This way, the communities are represented, and is part of the planning process. This is also a way to learn just how successful we are together as a region in having our own transmission company. It is amazing to know that together we have accomplished something that was considered impossible. Back in the early days of development, there were no accommodations being provided by the industry and government to allow a First Nations owned entity to come to fruition. It has been said by industry experts that Five Nations blazed a trail where no other has been before. This success has paved a way for other First Nation owned initiatives to be taken seriously. Hats off to everyone for having the courage and perseverance to make this company a success it is today!

We do have a few outstanding matters that need to be resolved and will continue to work in achieving the desired end result. We have received assurance that the second line that was recently constructed will be energized by end of this coming winter.

Most of our power outages have occurred and associated with the ongoing usage of the old transmission line that runs between Otter Rapids and Moosonee. This was something beyond our control but steps are being taken to complete this work. The parties involved have made commitments to get the work completed this coming season and we will make sure we hold them accountable.

There is also the business of the 80 kilometers of line that runs north of Moosonee which remains under the ownership of Hydro One. Five Nations is in the process of acquiring back this portion of the asset and will assume control of the full ownership of the transmission line. The timeline of this work will be a matter of when the financing can be secured. Most of these details can be shared by your own local representative who sit on the Five Nations Energy board of directors. This is where all discussions take place and where all decisions are made on behalf of the communities. Their involvement and participation are really appreciated.

In closing, we will continue to keep the membership informed in all developments of Five Nations Energy, and we also appreciate your input!

Chief Executive Officer's Message

The year 2014 is certainly going by fast and this past weekend, I was fortunate to spend time with family for the tradition of Thanksgiving festivities. I just love turkey and all the other trimmings that go with it to make it complete, and I am sure with Christmas around the corner, we will again be feasting on turkey real soon.

As with Christmas comes winter and snowstorms, and here at Five Nations Energy Inc. (FNEI), we certainly take precautionary measures in case of potential outages. Sometimes, an outage can last 24 hours or more depending on the severity of a storm and the location of the outage, whether it is a downed tree or something beyond our control. Our operations and maintenance department works closely with Hydro One to determine the location, and we, in turn, provide the information to the Local Power Corporations up the coast so they can inform their customers. We would advise everyone to be prepared in case of an unplanned outage and to have emergency kits on hand, and possibly to have an alternate place to go if it is more than 24 hours and I am sure all communities have emergency plans in place for this. Let us all think of safety and warmth this coming winter.

We will be starting community meetings in the coming months to look at developing and implementing Community Energy Plans for Attawapiskat, Fort Albany and Kashechewan. Funding is made possible by the Ontario Power Authority and is a two year project, and the goal is to have the community's input into current and future energy needs, priorities, and opportunities. Perhaps, a community may want to look at renewable energy and this is the opportunity to discuss at the local level, and the team will do the research on possible renewable energy projects. Our team is being led by Ms. Gail Lawlor and she is familiar with the communities, and was also instrumental in starting up the Conservation program in 2010 for FNEI.

The Conservation on the Coast program will be continuing for another five years starting in 2015 and this will built on the activities from the Conservation Demand Management Strategy that were initiated a couple of years ago in Attawapiskat, Fort Albany and Kashechewan. The goal of this program is conservation of energy, and lower electricity costs for house-holds. For more information, you can call your Local Power Corporation.

Year 2014 FNEI Operations Update:

Year 2014 passed in a blink of an eye. We have a few projects on the go, they made the year "run faster". We continued working on the right of way brush cutting, completed 22 km under M3K line.





No frost and soft ground have slowed down the job this year. Some of our equipment sunk in the muskeg and had to be rescued.





M9K Moosonee- Kashechewan Line pole #274 was fixed on February 9th. The pole top was split by the *lightning strike* last season. For repairs, the damaged part was cut off and sky wire (which carries fiber optics for internet) was reattached to the pole.

One of the big projects this year which will continue into next year is replacing and adding Transformer Substation yards stone. It is critical for maintaining isolation, safe levels of the step and touch voltages.





The stone has to meet insulation criteria, and samples were taken from several pits around Kashechewan and Fort Albany and sent to the specialized lab in Toronto for testing. The sample from the Fort Albany pit has acceptable results and we arranged the crushing and washing process to condition the stone. This project allows us to provide few employment opportunities for residents of Fort Albany. Next summer, we are planning to work at the Kashechewan Transformer Station yard on removing,

cleaning and adding clear stone.

FNEI has started working on the Bus isolation project, the system configuration will be changed to allow for better reliability and flexibility. Expect some extra outages during installation. Some jobs are already done in Fort Albany this season.

The installation included new breaker, relays, cables, voltage regulators and structure, to support them.

Besides new installations, the FNEI Operations Department continues routine maintenance and testing to keep an eye on the equipment conditions and keep it in good shape.
