

NOTICE OF A RATE HEARING

Five Nations Energy Inc. has applied to change its electricity transmission rates

Five Nations Energy Inc. (FNEI) has applied to the Ontario Energy Board (OEB) for approval to change its electricity transmission rates effective, January 1, 2026. The application seeks an Order for approval of the following:

- Revenue requirement for 2026, and adjustments for 2027-2030 based on an incentive ratemaking framework
- Inclusion of FNEI's approved revenue requirement in the OEB's determination of the 2026-2030 Uniform Transmission Rates
- Establishment of new deferral account to record anticipated but presently un-forecasted environmental remediation costs
- Use of the OEB's generic Incremental Cloud Computing Implementation Costs deferral account to facilitate the procurement of an upgrade to FNEI's asset management system

If the application is approved as filed, a typical residential customer and a typical general service customer of FNEI would see the following increase effective January 1, 2026:

| | |
|---|-------------------------|
| Residential (750 kWh) | \$0.03 per month |
| General Service less than 50kW (2,000 kWh) | \$0.07 per month |

Other customers, including businesses, will also be affected. Any change to the provincial transmission rate will be reflected on the delivery line of the electricity bill for all electricity customers in Ontario. It's important to review the application carefully to determine whether you may be affected by the proposed changes.

YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic and written. The applicant has applied for, and the OEB plans to proceed with, a written hearing. If you think a different hearing type is needed, you can write to us to explain why.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as Intervenor. After the hearing, we will decide whether to approve the application.
